Attention!

The auction schedule for this auction does not propose the reserved land plots for the construction of renewable energy facilities and available grid connection points. Potential auction bidders have the right to choose these land plots and connection points or to participate in auctions with their own land plots and connection points. In this case, if potential auction bidders have their own land plot and grid connection point they must provide supporting documentation on the availability of a land plot and a grid connection point for the construction of a renewable energy facility when registering in the trading system of KOREM JSC.

According to subparagraph 24) of Article 12 of the Land Code of the Republic of Kazakhstan, an entitlement document for a land plot is a document confirming the occurrence of juridical facts (set of facts), on the basis of which the rights to a land plot arise, change or terminate, including agreements, court decisions, legal acts of executive bodies, certificate of inheritance, deed of transfer or separation balance sheet upon reorganization of non-state-owned legal entities that own a land plot or purchased the right to temporary use the land for a fee (lease).

The following documents will be accepted as supporting documents for a grid connection point: a copy of the technical specifications for grid connection, issued and agreed in accordance with the Grid code, a copy of the letter of approval from the System Operator - "Scheme of Power Distribution" with the declared electrical capacity of 5 MW and more, developed in accordance with the Grid code. The required commissioning date for the BioPP project is 36 months from the date of signing the Power Purchase Agreement (PPA). The term of the Power Purchase Agreement (PPA) is 15 years
